



Meet Our Speakers

The Reverend Grace Imathiu ~ Diversity in Ministry

Rev. Grace Imathiu, Community UMC's lead pastor, was born and raised in Kenya and has one brother and three sisters. Her father is a retired Bishop of the Methodist Church in Kenya and received the 2005 World Methodist Council Peace Award for confronting Idi Amin's regime and South Africa's apartheid system. Her mother, a retired teacher, is a Local Preacher and has served in many leadership roles in the church.

Grace was educated in Kenya, the USA (Methodist Theological School in Ohio and Vanderbilt University in Tennessee), the University of Cambridge, and spent a year at the Hebrew University in Jerusalem. She was ordained in the Methodist Church in Kenya in 1988 and served six years in Kenya, and has since served in Washington, Ohio, Tennessee, and Wisconsin.



Grace is married to writer and science photographer David Hay Jones. They have one son, 14-year-old Erik, and a dog named Jack. David and Erik are devoted skiers. Grace and Jack do not ski.

The Reverend Young-Mee Park ~ Cross-Cultural Ministry & Experiences

Reverend Park is a second career clergywoman with the experience of living, working, and going to school in three different continents – Asia, Europe, and America. Rev. Park was born and raised in Korea, where most of her family members still reside. In her young adulthood, she went to France pursuing further education. After obtaining a BA, an MA, and a PhD degree in Linguistics, she returned to Korea and taught at both undergraduate and graduate levels. She then came to the United States in 2000 and went to Garrett-Evangelical Theological Seminary. Upon graduation from Garrett in 2003, Rev. Park was appointed to First UMC of Dixon as an associate pastor and then, in 2005, to First UMC of Oak Park, where she arrived as the first female and the first non-Caucasian pastor in the church's 135 years of history. There, Rev. Park led eight years of fruitful ministry, revitalizing the congregation and strengthening its mission.



Reverend Park returned to DeKalb District last summer to begin a new position as the District Superintendent. Having been "a foreigner" in many different places, Rev. Park is passionate about crossing boundaries and reaching out to all God's children. She firmly believes that it is the church's mission to bring down the dividing walls and to welcome all to God's loving embrace.

Reverend Park is married to Reverend Dr. Sang Hyeon Yoo, and they have two sons, Ihwan and Eunhwan.

Reverend Preston is the lead pastor of Kingswood United Methodist Church. Prior to the serving at Kingswood, he served six years as the Chicago Northwestern District Superintendent. 




What is the Leslie Bayles Memorial Scholarship Fund?



A BRIEF HISTORY

The Professional Association of United Methodist Church Secretaries was organized on April 14, 1982, in Dallas, Texas. Since the beginning, meetings have been held annually, a quarterly newsletter published, by—laws and logo adopted, working committees appointed, chapters organized, and Certification Institute established.

Legislation was adopted at the 1988 General Conference stating the General Council on Finance and Administration (GCFA) has the authority and responsibility: "To provide guidance and consultation for continuing education of church secretaries, including establishment of training and certification programs, and to provide assistance to the Professional Association of United Methodist Church Secretaries" (United Methodist Book of Discipline, 2012, ¶807.19).

The chain represents the vital link of the church administrator; the triangle within signifies the Trinity; and The United Methodist Church is represented by the cross and flame.

Who may become a member?
